Program Description

The Fire Suppression Skills Certificate prepares a student to fight structure and wildland fires at a basic level and prepares students to become National Fire Protection Association (NFPA) and Nevada certified at the level of Firefighter I. Upon completion student will have met or exceeded all national and state standards for NFPA/IFSAC Firefighter I, Hazardous Materials (Operational/Awareness), Basic Wildland Fire Fighter (S-110, 130, 190, L-180), and Incident Command ICS 100/200, NIMS 700/800.

This program takes place in the classroom and off campus for practical skills

This program is not eligible for financial aid. However, it may be eligible for scholarship funding if the student is awarded scholarships.

Program courses may not transfer to a baccalaureate degree of art or science within the universities in the Nevada System of Higher Education (NSHE).

Special Admission Requirements

Prerequisites - EMS 108 or current State of Nevada EMT certification and FT 101 Introduction to Firefighting or FT 102 Entry Level Firefighting or six months of fire experience.

Must show proof of CPR (Basic Life Support/Health Care Provider), health insurance, and be current on all vaccinations. In addition, a drug screening and a background check are required prior to the start of classes and must be 18 years or older.

To receive full NFPA/IFSAC Firefighter I students must provide a current State of Nevada EMT certification.

A Fire Academy orientation is mandatory. Students will be notified of specific dates and times with the acceptance email.

Due to the high mental and physical demand of this career, some accommodations that can be made in the classroom may not transfer to employment. Program Requirements

Skills Certificates can consist of a single course or a short set of courses that provide training for entry-level positions or career advancement. These short-term certificates may also prepare students to take state, national and/or industry-recognized certifications or licensing exams.

Skills certificates are awarded upon completion of coursework and marked on a student's transcripts at the end of the semester. Students cannot declare a skills certificate as one's major. Skills Certificates are not eligible for Financial Aid.

To earn a skills certificate, students must:

- 1. Maintain a minimum cumulative GPA of 2.0.
- 2. Have no financial or library obligation to the college.
